Bank Frick SFTP login

The Bank Frick server can be accessed using the Secure File Transfer Protocol (SFTP). This enables your banking data to be made available in electronic form (through CSV or PDF files) for connecting with your current software.

The data can be delivered as follows:

- CSV files with raw data; suitable for importing data and for analysis purposes
- · Position and transaction data
- Standard statements as PDF files, only in place of physical delivery

Users can choose between two different data packages:

- · Standard data package position and transaction data
- Customised data package larger, customised selection of data sets

Target group

Intermediaries, fund managers and other managers with, at a minimum, authorisation to receive information.

Type of access

Bank Frick makes data available on its own SFTP server. Access (pull by clients) is made secure through user ID, public/private key process and identification of the IP address.

Contract

Access authority is based on existing contracts. Access to the Bank Frick SFTP login is contingent upon the signatory power or power of attorney, or the authorisation to receive information.
